Green Filter USA warrants that its High Performance Air Filters are free from defects in material and workmanship and will last for the lifetime of your vehicle. This warranty will be honored for all Green High Performance Air Filters that are used in non-commercial vehicles under normal wear conditions. Green Filter USA reserves the right to refuse to honor this warranty for claims arising from, but not limited to, improper installation, accident, racing or competition use, neglect (including improper cleaning and maintenance), alteration of the product, or abuse. Green Filter USA's Limited Lifetime Warranty is valid for the original purchaser of the filter and is non-transferable.

Replacement of the filter shall be the sole and exclusive remedy to which Green Filter USA is obligated and to which the original retail purchaser is entitled. Green Filter USA shall not be liable for any consequential or incidental damages of any kind resulting from the order or use of its products. These damages include, but are not limited to, reimbursement of the original purchase price, and any other special, incidental, consequential, or punitive damages.

Any defective Green Air Filter properly returned to the factory will be replaced for a handling charge of \$9.95 USD. Green Filter USA will not be responsible for any costs incurred in making the warranty claim. Any warranty claim must be sent at the customer's expense along with proof of purchase. Green Filter USA reserves the right to determine if all terms of warranty have been met. Green Filter USA shall be under no obligation to honor this warranty.

To file a warranty claim please contact us at (724) 430-2050 and we will assist you. Proof of purchase is required for all warranty claims. Warranty returns will only be accepted by Green Filter USA when accompanied by a valid Return Merchandise Authorization (RMA) number. Replacements for defective products will be issued pending inspection. Product must be received by Green Filter USA within 30 days of the date RMA is issued.
